Chair Wolff called the meeting to order at 7:00pm.

**1. Roll Call**

**6. Ordinance 19-67: Amending the Text of the Zoning Code – City of Batavia, Applicant (DMR 10/24/19) CD**

Rackow discussed how the ordinance has definitions for items related to cannabis that has been legalized by the State with the Cannabis Regulation and Tax Act effective on January 1, 2020.

Rackow explained this is solely putting the definitions into the text of the Zoning Code and not changing the status of those uses.

**7. Water Street Studios – Forgive Loan Year 10 (PLC 10/22/19) GS**

McFadden overviewed the memo and noted that the loan was to be forgiven over a ten-year term for each successful year that Water Street Studios maintained minimum occupancy level.

**8. Discussion: Expansion of the Video Gaming Ordinance to Allow for Holders of a Class E-3 Liquor License (LN 10/24/19) GS**

Bob Hansen, owner of Funway, addressed the Committee. He stated that whether or not to incorporate video gaming has been a tough decision for him over the past few years. He was in support of video gaming because it is helping businesses survive. He is up against the same thing now. Due to the minimum wage increase it has been a huge number for them employing the age group that they have. They are looking for additional revenue.

Hansen stated the last thing that he wants to do is to ruin Funway's image. The gaming will be behind a wall in a storage area on the north side of their bar. It will be a three to four foot barn door that could be slid open or closed. The door will be closed and gaming will not be open when the bar is not open. When the bar is open there will be an attendant there and surveillance cameras will be in the bar area. He is not a big fan of gambling but it is an additional resource for them. It is open to many other businesses and he would like it open to his business as well.

The Committee members expressed their individual thoughts on video gaming in general and for this particular establishment. Newman observed that it appeared there was enough support to draft the ordinance to be brought back to Committee of the Whole (COW). Mayor Schielke asked staff to look into the cost for licensure of machines to ensure that it is not too low. Mayor Schielke stated he would ask legal counsel to prepare a memo about what the fees should be for COW's review.

## **9. Project Status**

Newman reported that IDNR is moving forward with plans to fund removal of low head dams. The City of North Aurora has been asked to update and renew their documentation requesting removal of their dam and indication has been given that perhaps Batavia could be next in line for that. This is great news but it prompts the question as to what we want to do with the depot pond, which is a primary feature of our downtown. If we want to maintain it then what would be the cost to do so. Newman stated that there is potential for CMAQ funding by continuing the berm at the end of the peninsula through Duck Island and then northwest to the other bank and if the bike path was continued over that. Newman explained that the removal of the dams would open up more of the river for recreational uses, such as canoeing and kayaking. There are also opportunities to increase the health of the fish population and increase that type of recreational use as well.

Chair Wolff asked that the Park District be involved as soon as possible with the discussion on the Depot Pond. Wolff stated that there is engineering money available with the CMAP if we can tie that to a plan with a bike path, especially with traffic issues we have in town. Wolff stated that is something we should explore immediately. Holm discussed the rules of the CMAP grant with the group and the importance of timing.

Newman reported that there are a number of businesses contacting our Economic Development Department wanting to establish their businesses in Illinois. Newman had a call from one of the communities that attended the Active Transportation Alliance meeting asking for pictures of River Street and documentation on how that all came to be because they wanted to present that information to their Board to show them what a similar investment can do for their community.

Newman reported that leaf pick up will continue and asked that leaves be moved out of the yard as soon as possible. She encouraged the community to mulch their leaves when they can.

## **10. Other**

Knopp thanked Chief Eul and Chief Diecke for their department's participation on Saturday leading the Batavia Marching Band out of town for the State Championship. They placed fifth in their class.

The Committee discussed conserving the reserves, income sources, general fund, balanced operating budget, 2020 census, EAV and the public notice. The consensus of the Committee was to go forward and publish the public notice. Colby noted that this would just establish a date for a public hearing and would not require the Council to pass any increase at all. It just means that it is being considered. Wolff asked for rate comparisons and no increase with going into the

reserves for the Committee to view. Colby stated that she would prepare a separate memo for this information.

Mayor Schielke discussed the potential of future development and revenue coming to the City. He suggested not posting a black box and go into the reserves. He stated that since there was a recent vote on keeping Home Rule, he does not want to give residents the wrong impression. Newman added that our rate could remain exactly the same but we would still need to publish the black box if our evaluation grows. Wolff commented that he does not want to put the City in the position where we don't have the reserves and we don't have the ability to do a small incremental increase. That is why he thinks the cap limits us and forces us to use the reserves that we have in small bits. If we don't have anything left in reserves we will ultimately have to raise taxes.

Shawn Viland, Batavia Parcel, applicant

**Summary:** Draft Ordinance 19-81 would grant a conditional use permit for a U-Haul Commercial Vehicle/Equipment Sales and Rental Business at 1921A West Wilson Street. The main business at this location is Batavia Parcel that provides business services (copy, print, shipping). For additional information, please see the [staff memorandum to the Plan Commission](#).

**Background:** U-Haul rentals have been available at Batavia Parcel for approximately 3 years, including before the applicant, Shawn Viland acquired the business. In working with Mr. Viland to locate his U-Haul vehicles to be compliant with the City's prohibition of vehicle signs, staff informed him of his need for conditional use approval for the vehicle rentals. Mr. Viland quickly applied for the required conditional use permit.

On November 6<sup>th</sup> the Plan Commission held the public hearing for the conditional use permit. Two (2) hearing attendees spoke in support of Mr. Viland and his U-Haul business. In response to Commissioner questions, Mr. Viland stated that he typically keeps eight (8) vehicles available for two-way rentals (6 vans, 2 trailers) and with one-way rentals, there may be up to approximately 15 vehicles total on the property. His business peaks on weekends when there's less demand for parking generally on the property. He parks longer length vehicles behind (east of) the building.

The Plan Commission noted the business can work well with other businesses on the property. The Commission felt that no U-Haul vehicles should be parked closer than 25 feet to the property lines along Randall Road or Wilson Street and no more than six (6) vehicles should be parked in front (west of) the building. The Commission arrived at positive findings as included in draft Ordinance 19-81.

**Alternatives:** The City Council can approve or deny the Ordinance as presented, or amended (if desired), or take no action.

**Impacts:** There would be minimal impacts with approval of the Ordinances. The U-Haul business has operated at this property without complaints from neighboring businesses. Mr. Viland notes that U-Haul rentals add to the volume of his business, adding sales tax revenue to the City.

**Timeline for Actions:** COW action will allow the Ordinance to be placed on the City Council agenda for final action on December 2<sup>nd</sup>.

**Recommendations:** By a vote of 5-0 (2 absent), the Plan Commission recommended approval of the Conditional Use Permit subject to the conditions listed in Ordinance 19-81. Staff recommends City Council approve Ordinance 19-81 as presented.

**WHEREAS**, said Applicant is requesting a Conditional Use Permit to allow operation of a U-Haul commercial vehicle rental business at 1921A West Wilson Street in the GC General Commercial zoning district; and

**WHEREAS**, notice was duly executed and the Batavia Plan Commission held a public hearing on November 6, 2019; and

**WHEREAS**, following said hearing, the Plan Commission made the following findings required for approval:

1. The proposed use will not be detrimental to health, safety, or general welfare of persons living or working in the vicinity, to adjacent property, to the neighborhood, or to the public in general.

**FINDING:** With Plan Commission recommendation of, and City Council approval of operational restrictions and vehicle parking and inventory with the Conditional Use, the proposed commercial vehicle rental business would not be detrimental to adjacent properties or the public in general.

2. The proposed use, as conditioned, conforms with the purposes, intent, and policies of the Comprehensive Plan and any applicable area, neighborhood, or other plan adopted by the City Council.

**FINDING:** Goal 1 of the Batavia Comprehensive Plan's Land Use Element stresses the need to balance land uses and maintain employment areas. The Plan's Economic Development & Redevelopment Element identifies the need to broaden land uses in the Randall Road corridor. The proposed use would complement the existing host business

and serve other businesses and residents of Batavia. The Randall Road corridor in Batavia currently has very limited commercial vehicle rental opportunity.

3. The proposed use conforms with the conditions, requirements, or standards required by the Zoning Code and any other applicable local, State, or Federal requirements.

**FINDING:** The proposed use would be located in an existing commercial space that can accommodate its needs. As conditioned, the business would operate in accordance with applicable laws.

4. The proposed use, as conditioned, would conform generally to the Zoning Code and applicable government requirements.

**FINDING:** As conditioned for approval, the proposed use would not interfere with the enjoyment of nearby properties.

**WHEREAS,** after making its findings, the Plan Commission recommended to the City Council approval of a Conditional Use Permit being granted subject to the following conditions:

1. The Conditional Use Permit be granted to Shawn Viland for U-Haul vehicle rental at 1921A West Wilson Street and is not transferrable.
2. The number of U-Haul vehicles (including trailers) on the premises at any time shall be limited to fifteen (15) with no more than six (6) vehicles located west of the building.
3. U-Haul rental vehicles/trailers shall be legally parked as close as practical to the pedestrian entrance door of 1921A West Wilson or east of the building, however in no event shall any U-Haul vehicle be parked closer than 25 feet to the property lines along Randall Road or Wilson Street to limit visibility of such vehicles from the adjacent streets.
4. Failure to comply with one or more of the requirements herein shall be grounds for revocation of the Conditional Use Permit.

**WHEREAS,** on November 19, the City Council's Committee of the Whole reviewed the application, the record of the public hearing, and the actions and findings of the Plan Commission and recommended approval of a Conditional Use Permit being granted to Shawn Viland for U-Haul vehicle rental at 1921A West Wilson Street, subject to the conditions recommended by the Plan Commission; and

**WHEREAS,** the City Council of the City of Batavia has considered the recommendations of both the Plan Commission and the Committee of the Whole.

**NOW THEREFORE, BE IT ORDAINED,** by the City Council of the City of Batavia, Kane and DuPage Counties, Illinois:

**SECTION 1:** The application for a Conditional Use Permit Conditional Use Permit by Shawn Viland to allow operation of a U-Haul commercial vehicle rental business at 1921A West Wilson Street in the GC General Commercial zoning district, is hereby approved with the following conditions:

1. The Conditional Use Permit be granted to Shawn Viland for U-Haul vehicle rental, 1921A West Wilson Street and is not transferrable.

3. U-Haul rental vehicles/trailers shall be legally parked as close as practical to the pedestrian entrance door of 1921A West Wilson or east of the building, however in no event shall any U-Haul vehicle be parked closer than 25 feet to the property lines along Randall Road or Wilson Street to limit visibility of such vehicles from the adjacent streets.
4. Failure to comply with one or more of the requirements herein shall be grounds for revocation of the Conditional Use Permit.

**SECTION 2:** That this Ordinance 19-81 shall be in full force and effect upon its presentation, passage and publication according to the law.

RE: ORD 19-77 AMENDING TITLE 3, CHAPTER 26 OF THE CITY CODE VIDEO GAMING DEVICES

Chapter 3, Title 26 of the City Code regulates Video Gaming Devices in the City of Batavia. 3-26-2 (B) states:

“B. No property owner or person in possession of property in the City shall allow a video gaming terminal to be placed or maintained on the premises unless the premises qualifies as a licensed video gaming location as defined in section 25 of the Video Gaming Act, including liquor establishments having a Class A or D license for consumption on the premises, licensed veterans establishments, licensed truck stop establishments, or licensed fraternal establishments and:...”

Approval of Ordinance 19-77 would allow the owner of a business holding a Class E-3 (bowling/amusement center) liquor license to have video gaming terminals on their premises, so long as all other requirements of the City of Batavia Video Gaming Code have also been met.

Pursuant to recent amendments to our local zoning code, video gaming is a conditional use for which any new, or expansion of an existing license requires approval by City Council. Therefore, even if Council votes to amend the Video Gaming ordinance to include E-3 liquor license holders, any business owner desiring to place video gaming terminals on their property would need to apply for approval of this conditional use.

There are benefits and potential detriments to allowing this requested expansion. Allowing it provides the owner of a bowling/amusement center the opportunity to earn additional income and to attract additional patrons to the business. The City also receives 6% share of the earnings from the additional machines. Of concern is the substantial presence of minors in such an establishment. However, the same could be said of restaurants geared toward children who hold Class D liquor licenses and are allowed under our current code to apply for a video gaming license. Therefore, so long as all other provisions of the code are met – in particular placing the machines in an area not accessible to patrons under the age of 21 – then this does not seem to be a relevant distinction that would preclude allowing E-3 license holders from also having video gaming.

Of course, it may be that Council prefers there to be no further expansion of video gaming to additional businesses of any type. Otherwise, Staff recommends that City Council allows expansion of Title 3, Chapter 26 Video Gaming Code to allow Class E-3 liquor license holders to be allowed to have video gaming terminals on their premises, so long as all other requirements of the City of Batavia Video Gaming ordinance have also been met.

In addition to allowing a new type of establishment to have video gaming terminals, Ordinance 19-77 also contains an increase to the annual site fee paid by the operator of the video gaming terminals from \$1,000

per year to \$1,500 per year. Such an increase is justified by the substantial cost to the city for oversight of video gaming in the community.

Staff recommends approval of Ordinance 19-77 AMENDING TITLE 3, CHAPTER 26 OF THE CITY CODE VIDEO GAMING DEVICES.

**WHEREAS**, the City of Batavia’s Municipal Code currently allows certain types of entities located within the City to obtain a license to have video gaming devices on their premises, but not businesses that hold an E-3 (Bowling/Amusement) liquor license; and,

**WHEREAS**, the City has considered and supports allowing the expansion of the type of entities allowed to apply for a license to have video gaming on their premises to include businesses that hold an E-3 (Bowling/Amusement) liquor license; and,

**WHEREAS**, the City has determined that its cost of allowing video gaming terminals is substantial and warrants an increase of the annual fee paid by operators of said terminals from \$1,000 per year to \$1,500 per year.

**THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Batavia, Kane and DuPage Counties, Illinois, as follows:

**Section 1.** That Title 2 of the Batavia City Code is hereby amended instanter with the following words, phrases and numbers:

...  
**3-26-2: LICENSE REQUIRED; LIMITATIONS:**

...  
B. No property owner or person in possession of property in the City shall allow a video gaming terminal to be placed or maintained on the premises unless the premises qualifies as a licensed video gaming location as defined in section 25 of the Video Gaming Act, including liquor establishments having a Class A, D or E-3 license for consumption on the premises, licensed veterans establishments, licensed truck stop establishments, or licensed fraternal establishments and:...

4. The gaming terminal operator has paid the annual location permit fee of one thousand dollars (\$1,500) for the licensed video gaming location.

**Section 2.** Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction, the remaining provisions will remain in full force and affect the same as if the invalid provision had not been a part of this Ordinance.

**Section 3.** This Ordinance shall be in full force and effect after passage and publication pursuant to law. Publication date: December 2, 2019. Effective date: December 2, 2019.

**SUBJECT:** Budget Adjustments

**Summary:** The Budget discussion on November 12<sup>th</sup> ended with the City Council choosing to keep the tax rate the same as last year and to use reserves to cover both the operating deficit and the capital deficit. The City Council also supported leaving the transfer of \$1,000,000 from the General Fund to the Capital Fund in the budget.

There have been no other changes to the budget except for two changes to Fund 43 (Street Capital). The engineering department just received notice that the City may move forward with design engineering for the second phase of Prairie Street Reconstruction. Stage 2 will involve reconstruction of Prairie Street north of Laurel Street to Wilson Street. Railroad gates will be installed at Prairie Street just south of Wilson Street along with traffic signals at the Wilson and Prairie Street intersection. The City will only need to contribute 30% of the cost for the project which is planned for construction in 2022. I have added \$238,000 in 43-47 for the design engineering and \$166,600 in 43 grant revenue. There will be sufficient funds available to do the project at that time and the City should accept the grant funding of \$1.8M for 70% of the project costs. The City share of the project will be \$765,750.
