SUBJECT: Resolution 19-047-R: Authorization to Purchase One 2019 Ford F250 Truck from Landmark Ford, Inc. for \$36,613.00

Summary

The Street Division is recommending the purchase of one 2019 Ford F250 truck through the State of Illinois Joint Purchasing Program.

Background

This truck would replace a 2008 Ford Escape SUV with a full-size F250 truck with plow. It would be used in our daily operations by the Assistant Street Superintendent and also for plowing parking lots and cul-de-sacs during winter operations. The Escape will be surplus and auctioned when the replacement is received. We have budgeted \$37,000.00 for the expense in 2019. The total cost of the truck will be \$36,613.00. The State of Illinois Joint Purchasing Program is the most cost-effective option.

Staff Recommendation

Staff recommends the purchase of the one 2019 Ford F250 truck through the State of Illinois Joint Purchasing Program from Landmark Ford, Inc. of Springfield, Illinois.
