RE: Resolution 21-078-R: Approving a Change Order to the contract with Electric

Conduit Construction to build a Fiber Hut/Critical Infrastructure Communication Node Shelter at Paramount Substation for an amount not to exceed \$26,699.99

### **Background:**

Through Resolution 20-134, the City Council authorized Electric Conduit Construction (ECC) to construct a communication building at Paramount substation for an amount not to exceed \$266,677.

### **Discussion**

The project has been completed and all communication fiber have been transferred to the communication building. However, during the final invoicing process, staff and the contractor discovered a math error on the unit items that were presented during the bid process. Instead of multiplying the unit price with the quantity and adding the total item cost as the final bid price, contractor just added the unit price for some items for the total bid price. As a result, ECC bid price was lower than what it should have been. If we correct this math error, then the total completed price for ECC contract would be \$293,376.99. The table below shows that if we would have found this math error prior to authorizing the contract, then ECC still would have been the lowest bidder and would have been authorized the contract.

ECC performed satisfactorily for this project. Given the facts that, it was a math error during the bidding process, and the math error does not change the apparent lowest bidder and a budget amendment will not be necessary for this change, staff is comfortable in recommending the change order for ECC.
