Special Revenue Funds

Special revenue funds are required to account for the use of revenue earmarked by law for a particular purpose. The Special Revenue Fund is considered a Non-Major Governmental Fund for Audit purposes.

Motor Fuel Tax

This fund accounts for the receipt and use of motor fuel taxes distributed by the State. Any street improvements funded with Motor Fuel Tax revenues must be approved by IDOT. Any improvements that are not eligible for use of Motor Fuel Tax funds are paid for out the Street Improvements Capital Fund.
